BANKRUPTCY ORDER

UPON THE APPLICATION OF NORSK SJOMAT AS, a creditor, filed on the 15th day of May, 2014, and upon reading the said Application and the Affidavit of Verification of Luis Guadamos filed, and it appearing to the Court that the following acts of bankruptcy have been committed:

(a) Nordic Gold Salmon Products Ltd. has ceased to meet its liabilities generally as they become due; and

(b) Nordic Gold Salmon Products Ltd. has given notice that it has suspended payment of its debts.

1. **IT IS ORDERED** that Nordic Gold Salmon Products Ltd. be and is hereby adjudged bankrupt and a Bankruptcy Order is hereby made against the said Nordic Gold Salmon Products Ltd.
2. **AND IT IS FURTHER ORDERED** that Collins Barrow Toronto Limited of the City of Toronto, in the Province of Ontario, be and is hereby appointed Trustee of the estate of the said bankrupt.

3. **AND IT IS FURTHER ORDERED** that the said Trustee give security in an amount to be fixed by the Official Receiver pursuant to subsection 16(1) of the *Bankruptcy and Insolvency Act*.

4. **AND IT IS FURTHER ORDERED** that the costs of and incidental to this Application and of this Order be paid to the Applicant out of the assets of the estate of the said bankrupt forthwith after taxation thereof.
